


INSTALLATION INSTRUCTION :

After CSUTax 2018 installation finished, on Login screen:




- **Firm Name: YOUR COMPANY NAME**
- **Key Code: FREE TRIAL or Assigned Key code**
- Click on **Login**
- Enter your company information. Click **"Save"**.
- Now use it for your business.

➤ Import Last Year CSUTax 2017 Database:

If you used the CSUTAX2017 last year, you can transfer your 2017's client information to the current CSUTAX2018:

- **Backup your 2017 database.**
- **Open CSUTax 2017;** Click on **"Database"**. Choose and Click **"Export"** to Backup your 2018 database. Close CSUTax 2018.
- **Open CSUTax 2018.** From CSUTax 2018 Main Menu, click on **"Database"**.
- Click on **"Import"**.
- Choose **"2017"**. Find the 2017 database. Exp.: C:\CSUTax 2017\Database\CSUTax.mdb.
- and click on icon **"Import"** to make a transfer.
